What is Human Trafficking?

Human Trafficking is compelling or coercing another person's labor or services (including commercial sex acts). The coercion can be subtle or overt; physical or psychological.

Coercion Means

- (a) the use or threat of force against, abduction of, serious harm to, or physical restraint of a person;
- (b) the use of a plan, pattern, or statement with intent to cause a person to believe that failure to perform an act will result in the use of force against, abduction of, serious harm to, or physical restraint of a person;
- (c) the abuse or threatened abuse of law or legal process;
- (d) controlling or threatening to control a person's access to any substance defined as a dangerous drug pursuant to Title 50, chapter 32, parts 1 and 2;
- (e) the actual or threatened destruction or taking of a person's identification document or other property;
- (f) the use of debt bondage;
- (g) the use of a person's physical or mental impairment when the impairment has a substantial adverse effect on the person's cognitive or volitional function; or
- (h) the commission of civil or criminal fraud.



Montana Laws

Patronizing Prostitute 45-5-601:


- o 1st offense-Up to 5 yrs. and \$5k fine
- Subsequent Offense(s)- Up to 10 yrs. and a \$10k
 fine
- If the person Patronized was under the age of 18-100 yr sentence mandatory minimum of 25 yrs.

Sex Trafficking 45-5-702:

2 to 20 yrs. and a maximum \$50k fine.

Labor Trafficking 45-5-703:

• 15 yr. max sentence and a maximum \$50k fine.



Montana Laws

Patronizing a Victim of Sex Trafficking 45-5-705

- 1st Offense- 15 yr max and a \$50k fine max
- o 2nd Offense- 2-15 yr max and a \$50k fine max.
- If the person Patronized was under the age of 18-100 yr sentence mandatory minimum of 25 yrs.

Aggravated Sex Trafficking 45-5-706:

5-40 yrs. Max and a \$50k fine max







Estimated that 5.5 million are children




Currently over 1M victims of human trafficking in the United States.

Why is it growing?



Human trafficking is the fastest-growing criminal business in the world, according to the State Department. It ranks only second to drug trafficking in profitability, bringing in an estimated \$236 billion annually.

Humans can be sold over and over again while a drug can only be sold once.


Average price for time with a victim is \$90.00 (USC) Average price for a gram of meth in Montana is \$70.00 (USC)



Sex trafficking: Why is it expanding?

Society has normalized commercial sex (victimless crime) and glamorized pimping.

Pornography is available in almost every household in America.



The majority of those trafficked are young adults between ages 14 and 24

Almost all have experienced either sexual exploitation, violence, or forced drug use, during their time being enslaved.

How did they get where they are?

Internationally it is due to migrating in search for better conditions: poverty, oppression, lack of human rights, lack of social or economic opportunity, dangers from conflict or instability.



Causes locally

Commercial Sex Trafficking Stats

3 in 4 adult prostitutes were introduced into the sex trade as minors.

1 in 3 minors living on the streets will have an attempt to be lured in within 48 hrs.

Average age of minors involved in prostitution in U.S. =14 years of age


Pimps can profit in excess of \$100,000 per year with 1 victim. Average pimp controls 3 victims at a time.

Factors in Recruitment

Target vulnerable victims: runaways, homeless, abusive home life, substance abusers, mental disabilities, poverty.

- Provides basic needs: attention, flattery, money, drugs, alcohol, then facilitates sexual "tryouts".
- Convinces victim of their love then exploits their insecurities.
- Praise's victims "sexual maturity".
- Supplies drugs, housing, or clothing, then demands payback







- Stop Enabling Sex Traffickers Act (2018)
- SESTA: To amend the Communications Act of 1934 to clarify that section 230 of that Act does not prohibit the enforcement against providers and users of interactive computer services of Federal and State criminal and civil law relating to sex trafficking.
- Allow States and Victims to Fight Online Sex Trafficking Act (2018)
- FOSTA: A bill to amend the Communications Act of 1934 to clarify that section 230 of such Act does not prohibit the enforcement against providers and users of interactive computer services of Federal and State criminal and civil law relating to sexual exploitation of children or sex trafficking, and for other purposes.



Other Indicators

Minor that is not related to a non-age-appropriate male or with an overly controlling "boyfriend" or another female

Traveler has someone speaking for him/her



Possession of large
amounts of cash, pre-paid
cards, money grams, or
hotel key cards and
receipts

Wearing clothes that do not fit the climate or the situation such as short shorts or skirts, tank tops, and no jacket in the middle of winter

Traveler is unable to provide details regarding their location of departure and/or flight information and/or destination

Possession of more than one cell phone


Young person that is very hesitant to engage in conversation. Eyes are always downcast, avoiding eye contact, especially with men.

Traveler is an adult and is not carrying their own identification documents

Traveler does not have any personal luggage

Individuals who wait at a table or bar and are picked up by a male (trafficker or customer)


Traveler shows signs of physical abuse



A group of people, or an individual, traveling for an unrealistic/vague/ suspicious job offer



A person buying plane tickets with cash instead of credit or debit card; particularly take note if this individual is buying a large number of one-way tickets



Labor Trafficking

Two Main Types

Bonded Labor

Victims become bonded laborers
 when their labor is demanded as a
 means of repayment for a loan or
 service in which its terms and
 conditions have not been defined or in
 which the value of the victims'
 services as reasonably assessed is
 not applied toward the liquidation of
 the debt.

Forced Labor

 A situation in which victims are forced to work against their own will, under the threat of violence or some other form of punishment, their freedom is restricted, and a degree of ownership is exerted.


Mat Is Continued Presence?

A temporary immigration designation for noncitizen victims of human trafficking cooperating with law enforcement who may also be potential witnesses.

So, what are we doing locally?



Local Legislation added SB147 2019

- Changed definition of prostitution to include hand jobs not just intercourse.
- Added aggravating penalties for pimps.
- Added aggravating penalties if the patron knew or should have known that the victim was a trafficking victim.
- Added Sex Trafficking and Aggravated Pimping to the list of Crimes of Violence.
- Changed the definition of "consent" so that it can not be a defense if the offender knew or should have known that the victim was a trafficking victim.

House Bill 112 2023

Reformed current trafficking laws

Added Child Sex Trafficking


Patronization of a prostitute became a felony on the 1st offense. Second state in the nation to do this, behind Texas.






House Bill 2 2023


